This release is entered into between the undersigned and WoW! Boot Camp. WoW! Boot Camp agrees to provide workouts and other services as described in the boot camp materials provided at orientation (hereafter incorporated by reference.) The under-signed, hereafter referred to as "Participant" agrees to the following conditions:

Participant expressly waives, releases, discharges, and agrees not to sue WoW! Boot Camp, April Williams, or any other individuals associated with WoW! Boot Camp for any liability from death, disability, personal injury, or action of any kind resulting from voluntary participation in this fitness program. Furthermore, Participant agrees that her heirs, executors, administrators and /or assigns relinquish any action or causes of action which may arise regarding her estate, and agree that under no circumstances will her heirs, executors, administrators and /or assigns prosecute or present any claim for personal injury, property damage, loss of consortium, or wrongful death against the above organization, April Williams, or any other individuals associated with WoW! Boot Camp, regardless of whether or not negligence can be shown on the part of any said persons or organization.
